In 2018, the Township developed a Go! Green Master Plan that includes the opportunity for green burials at our cemeteries. A green burial is a burial without many of the characteristics we have become accustomed to in modern time. To take advantage of a green burial, no embalming can take place, no vault can be used, no headstone will be placed on the grave after burial, and nothing can be placed in the burial space unless it is biodegradable. The pilot for this opportunity was launched in our West Oshtemo Cemetery located near the corner of 1st St. and Almena Dr. Since then, we have sold many plots for future burials, and I am happy to announce that we had our first green burial occur this month. Oshtemo currently offers the only green burial option in Kalamazoo County, but be on the lookout for other municipalities to develop their own green burial plans. Tax bills will be sent out at the beginning of July and are due by September 14, 2022. If you do not receive a tax bill, and believe you should have, contact my office as soon as possible to avoid late fees. We encourage you to mail your tax payment to 7275 West Main, Kalamazoo, MI, 49009, or make use of the convenient outside drop box in the Township Hall parking lot. Another option is to pay your taxes online at www.oshtemo.org (Please note: A fee is charged by the credit processor for online payments.)

Tax payments are updated daily on the website. If you would like a receipt, please contact the Treasurer's office (269-216-5221) and one will be sent to you.

A 1% late fee will be charged for summer taxes paid September 15-30, 2022, and a monthly 1% late fee will be charged from October – February 2023 until the taxes are paid.

From Supervisor Heiny-Cogswell—

An important update on the sewer expansion—the Circuit Court ruled June 8th to uphold the Clerk's finding that referendum petitions were insufficient. From this decision, the sanitary sewer expansion and road reconstruction projects can proceed. Township staff is working closely with USDA, bond counsel, municipal finance advisors, and consulting engineers on when and how next steps may unfold. Many are likely aware of the current state of construction—less contractor availability, increases in the cost of materials, and longer supply chain timelines to obtain materials. This will affect the bidding and construction timeline. Most likely the bidding will include specifications for the contractors to have increased time to gather materials and to complete the work.

Another update on the Oshtemo Residents Association challenge to the validity of the township's sanitary sewer connection fee claiming that it was a tax and violation of Headlee as well as a violation of equal protection. The Circuit Court struck down both claims and upheld the validity of the township's sanitary sewer connection fees. The Oshtemo Fire Chief search continues. No decision at time this article is written.

The Township Board held multiple public discussions on the Federal American Rescue Program Act (ARPA) funds and prioritized their use. Citizens, Departments, and Board members contributed suggestions, and those ideas were all on the table. Please know some ideas not prioritized for funding were noted to remain important, but to have other possibilities for funding, such as the General Fund tax dollars, or other grant programs. One example of this is the expansion of broadband in underserved areas of the Township. The broadband expansion remains a priority. There are State grant programs for this, so the Oshtemo local ARPA dollars were not identified for this use. The Supervisors of Kalamazoo County Townships previously joined together to apply to the County for use of the County ARPA funds for the first step in assessing the need for broadband expansion—a thorough identification and mapping of broadband services as they currently exist throughout Kalamazoo County. The funding priorities for use of the ARPA funds identified by the Board are shown elsewhere in this newsletter.

In closing, the negotiations between Townships and the City of Kalamazoo on the Wastewater contract are to commence in July.

One Tennis Court to be Converted to Two Pickleball Courts at Oshtemo Township Park


The tennis courts at Oshtemo Township Park, located behind the Township Hall at 7275 West Main Street, will be resurfaced this summer and one of the tennis courts will be converted into two pickleball courts, as shown in the sketch at right. The work is expected to occur in July and will cause the courts to be closed for five days.

The idea to convert a tennis court to pickleball courts came from numerous appeals for pickleball over the past few years, coupled with reports of positive experiences from similar conversions in Kalamazoo and Parchment. The Parks Committee requested feedback on the idea in the April newsletter and received over 100 responses by online survey or email. Support for pickleball courts was strong. Here's a sample of some of the responses received:

- Would love the pickleball courts! We are close by and would play a lot!
- Thank you for seeing the need for pickleball courts to accommodate this popular activity that is open to all ages to play.
- This will add more options for physical activity in the community, which is great!
- Thanks for considering this. Pickleball is a fast-growing sport that is so much fun. I love seeing people of all ages out playing. It's cheap to play and a little easier physically than tennis.

Oshtemo Township receives \$150,000 Planet Award grant from Consumers Energy Foundation

The Consumers Energy Foundation presented a \$150,000 Planet Award grant to Oshtemo Township at a grant ceremony on Wednesday, June 8, 2022. Grant funds will be used to restore habitat in a two-mile section of the historic Fruit Belt Rail Corridor, along with environmental education and stewardship opportunities focused on climate resilience. Kalamazoo Nature Center's Conservation Stewardship team, a partner on the project,

will provide most of the ecological restoration activities and environmental education programming.

Oshtemo Township purchased the former rail corridor property from ATT in November 2021 using grant funds from the Michigan Natural Resources Trust Fund (MNRTF). A condition of the MNRTF grant is that the land be dedicated to public recreation and natural resource protection in perpetuity. Ecological restoration work by the Kalamazoo Nature Center is starting with a survey to identify and assess plant species, which will be ongoing during the 2022 growing season. A plan for invasive species management and native plantings will be developed later this year. The project is expected to be completed at the end of 2023.



FOUNDATION



The project site extends from 9th Street to Oshtemo Township's southern border with Texas Township. Acquisition of this section of former rail corridor was a priority in part because it abuts Flesher Field Park, 3664 South 9th Street. Park visitors can enjoy hiking, birding, or dog-walking on the former rail corridor. Temporary directional signage is in place at the north

News from the Oshtemo Fire Department

From the notes of Interim Fire Chief Ron Farr-

I am Ronald Farr and I have the honor of serving as your Interim Fire Chief while the "Fire Chief Search Committee" does a Nationwide search for a new Fire Chief to fill the role of Retired Chief Mark Barnes.

I have been an active member of the fire service in Michigan for 54 + years starting as a Paid-on-Call member of the Plainwell Fire Department in 1967. In 1972 I went to work full time for Kalamazoo Township serving as a police officer, Fire Marshal, Deputy Chief and then Chief of the fire department the last 6 + years. Upon retirement from Kalamazoo Township (after 37 years) I was appointed Michigan's State Fire Marshal under Governor Granholm's administration. When things transitioned to a new administration, I chose to go to work for Underwriters Laboratory (UL) in Northbrook, IL serving in their Regulatory Services Division for 6+ years.

Ron is married to Wendi, his wife of 27 years, and has two kids and two grandchildren.

From the notes of Training Officer Captain Eric Burghardt-

For your safety and protection please test your smoke alarms and make sure they are functioning. Thank you and remember to Stay Safe.

"Get ready, stay ready" is a motto we use in the fire service to remind ourselves that our residents, visitors and fellow firefighters are counting on us. Firefighters "get" ready during the fire academy and initial training at their fire department. They

"stay" ready through continuing education and fire service experience. We are always looking for innovative ideas to keep our training up-to-date, relevant and exciting. To accomplish this goal, we rely heavily on the citizens we service to supplement our in-house training opportunities. For example, last year H&K Excavation allowed us to conduct Trench Rescue training on their property and provided the equipment and personnel to make a realistic trench. Several of our apartment complexes have been gracious enough to allow our Fire Department to utilize a vacant apartment or one of their stair wells to train on high rise fire suppression operations. Every so often a citizen will even donate a house, scheduled for demolition, for us to train in. These acquired structures are one of the most valuable training assets we can obtain. We are currently in possession of a two story, residential structure on 3rd St. We will have this structure for several month to perform realistic fire suppression training. Since April we have conducted 48 hours of training in this acquired structure. Subjects range from search and rescue, chainsaw operations, ladder training, and fire suppression techniques. The Oshtemo Township Fire Department does not operate without support from our neighbors, so we invite them to train with us too. Texas Township, Kalamazoo Department of Public Safety, Ross-Augusta Township, Comstock Township, South Kalamazoo County Fire Authority, and Mattawan Fire Departments have all participated in training with us.

It cannot be overstated, these contributions from our citizens not only make Oshtemo Township Fire Department better but also improve the county and regional emergency response network. We are dedicated to getting our new firefighters ready and staying ready through excellent training. This will allow us to provide the best possible service with ... respect, responsibility, and pride.
