Regular Board Meeting January 23, 2024 5:30 PM

The Oshtemo Township Public Meeting was held in person at the Township Hall. Residents were able to give public comments during the meeting. Supervisor Bell called the meeting to order at approximately 5:30 PM.

Public Comment

Supervisor Bell opened public comment. One person spoke.

Public Officials Update

Kalamazoo County Commissioner Dale Deleeuw provided a County update. The application for the County Opioid Task Force closes on January 27, 2024. He also updated the Board regarding medical debt forgiveness.

Discussion: Township Trash Day

Clerk Farmer shared with the Board that the current model for Trash Day has been evaluated by Maintenance Director Greg Fountain since about May of 2023. He gathered names and addresses at each Trash Day so that the Township could evaluate how many residents are using the service, and where those residents live within the Township. Maintenance Director Fountain identified safety concerns for both residents and Township staff and provided a recommendation to have up to three maintenance workers on site for the Trash Day events. This recommendation resulted in identifying staffing solutions and costs to taxpayers. During this process investigation began to offer trash removal services away from Township property. One-time pick-up services from each residence was projected to cost the same as 10 Trash Days at the Township. The Township trash haul company offered a system of certificates to residents so that they could bring large amounts of trash to the Miller Rd transfer station at any time throughout the year, possibly opening up service to more residents and addressing the safety concerns for staff on Township property. This will come back to the Board at a later meeting.

Motion by Cole, second by Chapman to accept the Transportation and Mobility Ordinance for first reading and set for second reading on February 6, 2024. Motion carried 6-1.
