Township Board Special Meeting January 24, 2017

The Oshtemo Township Board special meeting was held at the Oshtemo Community Center. Supervisor Heiny-Cogswell called the meeting to order at 12:05 p.m.

Rural Development Loan and Sewer Extensions

Discussion led by Matt Johnson of Fleis & Vandenbrink regarding the Oshtemo Sanitary Sewer Capital Improvement Plan. The cost of all sanitary and water extensions is around \$45 million. When categorizing sewer projects into different timeframes, Phase 1 cost would be about \$25,320,000. Three ways to pay down the debt were presented to the Township. A 20 year issue at 4% interest would obligate the resident to pay a range from \$88-\$50 per month over twenty years. A 25 year issue at 4% interest would obligate the resident to pay a range from \$79-\$41 per month over twenty years. A Rural Development 40 year issue at 4% interest would obligate the resident to pay a range from \$67-\$24 per month over fourty years. Consultants from Fleis & Vandenbrink will be available for questions at the next board meeting, February 14th. The Board discussed beginning the next work session at 5 PM for more discussion and to have additional opportunity for public comment.
