Public Comment

Supervisor Bell opened public comment.

Public Officials Update

Kerry DenBraber from the Michigan Department of Transportation provided updates to the Board regarding the US 131 bridge over KL Ave., the US 131 Business Route construction, M43/West Main from 10th St to Drake Rd., and lane widening from I-94 west bound to US 131 Parkview bridge (and possibly as far as the Stadium Dr. bridge). MDOT will keep the Township updated as project dates are closer, and they will provide information for communications with the public.

First Reading: Text Amendments Floodplain Management Ord 510, Section 273.003

Motion by Ford, second by Chapman to approve the proposed text amendments to Ord 510, Section 273.003 for first reading, and set second reading for April 9, 2024. Motion carried 7-0.

Resolution: Intergovernmental Agreement

Motion by Ford, second by Sikora to adopt the Michigan Community Resolution and Intergovernmental Agreement to Manage Floodplain Development for the National Flood Insurance Program. Roll call. Resolution adopted 7-0.

Discussion: Lawsuit Update and Sanitary Sewer Funding

Attorney Porter provided an update to the Board regarding the lawsuit for the USDA Bond petitions, and he expects oral arguments to be scheduled soon.

Public Works Director Anna Horner provided the Board with information about types of funding for sewer projects other than USDA Bonds. With the delay from litigation, the sewer installation has become much more expensive and will require additional methods of funding. The Board will need to discuss and decide how to move forward to accomplish all identified sewer projects. The Board requested further information regarding the requirements for each option.
