IT Work Discussion

- a. North Conference Room Projection System- Treasurer Culp and Grant are going to compile information and use the feedback from the IT Work Group. The proposal with budget amendment can be brought to the next regular Township Board meeting. Feedback includes accessibility for everyone in the room, proper cord management, looking into kits with mounting options, bringing multiple options for the Board to consider. In addition, the entire project should not exceed \$2000. The need for more rooms to have presentation capabilities will be evaluated in the future.
- b. **Assessing Property Records Digitization** The Assessing Department will have time after the beginning of April to evaluate the records to decide how long it might take to organize the files, prepare them for scanning, and scan them into the system. Board consensus is to complete the trial, document the time it takes, and then the Board can decide how to move forward.
- c. NAS- Jon was unable to attend the meeting, so this item will be moved to the next IT meeting.
- d. **Inventory** (ongoing)- The purpose was to identify the number of machines being used, who is using them, and for what purpose. This can inform the rotating schedule for hardware replacements. No need for RAM, operating system, CPU. The Board only needs to look at the use of each machine. The other purpose is to properly manage the inventory and identify lost or moved equipment. This will be presented during the budget process.
- e. **Rotating schedule for hardware replacements** (ongoing)- same as inventory. Should be presented during the budget process.

Consideration of Drake Farmstead Barn Design Consultant Work

Parks Director Karen High presented the request to amend the budget from within the Parks fund to redesign the carriage barn at Drake Farmstead Park so that it can be bid out within budget. This request should ultimately save about \$60,000 in construction costs.

Motion by Culp, second by Hudok to amend the budget for \$6,000 and to increase the consultant line item in accordance with the request.

Resolution Proclaiming April as Child Abuse Prevention Month

Motion by Heiny-Cogswell, second by Ford proclaiming April as Child Abuse Prevention Month. Roll Call. Resolution adopted 7-0.
