## **Resolution Proclaiming April as Child Abuse Prevention Month**

Sarah Joshi was present as the Executive Director of the Kalamazoo County Child Abuse & Neglect Prevention Council. Clerk Farmer noted that there were over 6500 complaints of suspected maltreatment of children received by Kalamazoo Child Protective Services in 2016.

Motion by Ford, second by Farmer to declare April as Child Abuse Prevention Month. Roll call. Resolution adopted 7-0.

# **Consideration of Bicycle Five Foot Passing Distance Ordinance – First Reading**

Attorney Porter presented the amendment to the Township traffic code ordinance with the intention of providing increased safety for bicyclists. Trustee Ford suggested signage to educate the community about the increased passing distance. Attorney Porter said that there will have to be some discussion with the Road Commission of Kalamazoo County. Trustee Ford clarified that he was thinking that vinyl signs or banners could set up around the Township to educate the public. Trustee Bushouse said that he supports a digital sign in front of the Township Hall to help educate the community.

Township resident Mike Boersma mailed Supervisor Heiny-Cogswell to share that he is in support of the ordinance amendment.

David and Jill Sluyter shared that they are in support of the ordinance amendment.

Motion by Ford, second by Everett to accept the ordinance with an amendment that if a car is unable to allow 5 feet it will proceed with caution, and to set Second reading for April 25<sup>th</sup>, 2017. Motion carried 7-0.

### Sanitary Sewer Extension Phase I – USDA-Rural Development Grant & Loan Program

Motion by Ford, second by Hudok to authorize the Supervisor to enter into agreement to conduct an Environmental Report for the USDA Rural Development Grant and Loan program full application; the cost of the report is \$10,000. Motion carried 7-0.

### **Other Township Business**

Trustee Hudok asked if the FAQs for the USDA Rural Development Grant and Loan program are available online, and both the Clerk and Supervisor confirmed that they are on the website.

Trustee Hudok also asked about the current truck route in the Township. Attorney Porter explained that the last Board decision on the matter was to leave the route as is and monitor complaints in the future.

Motion made by Trustee Bushouse, second by Ford to add an agenda item to a future Board meeting to receive three bids for a digital sign in front of the Township Hall. Supervisor Heiny-Cogswell suggested that we get a design and quotes and bring them before the Board for discussion. Trustee Bushouse agreed to amend his motion, and Trustee Ford supported the amendment. Motion carried 7-0.

Supervisor Heiny-Cogswell shared an updated memo regarding the Grange Hall 2017 Addition and Renovation.
