Approval of the Agenda

Motion by Sikora, second by Ford to approve the agenda with the recommended changes from Supervisor Bell. Motion carried 7-0.

Public Officials and Community Partner Update

Road Commissioner Larry Stehouwer was available for questions or concerns.

Brownfield Tax Increment Financing Policy

Planning Director Jodi Stefforia reviewed the changes to the current criteria in the policy to promote discussion with the Board.

Public Comment

Supervisor Bell opened public comment.

Supervisor Bell asked if anyone present wished to remove items from the consent agenda and table to a future meeting. Trustee Ford asked to remove item e.

Motion by Ford, second by Sikora to approve the consent agenda items a, b, c, and d and table item e until May 13. Motion carried 5-0, with two absent.

Resolution: USDA Construction Contract

Public Works Director Anna Horner presented the resolution and change order.

Supervisor Bell opened public comment. No public comment.

Motion by Ford, second by Sikora to adopt a resolution to conditionally award the construction contract for USDA Neighborhood Sanitary Sewer expansion to Redline Excavating Company, including the change order. Roll call. Resolution adopted 5-0, with Buszka and Cole absent.

Consideration: Streetlight Projects

Project Manager Zach Pearson provided an overview to the Board.

Supervisor Bell opened public comment. No public comment.

Motion by Ford, second by Chapman to adopt a resolution authorizing Consumers Energy to make changes to the standard lighting contract. Roll call. Resolution adopted 5-0, with Buszka and Cole absent.

Discussion: MI House Appropriations Request

Supervisor Bell shared the letter that would have to be signed to make appropriations requests to the State. The letter requires a statement from the Township stating that it will not impede immigration enforcement efforts through ordinance or policy. The Township has no authority regarding immigration, and it is unclear if this requirement is legal. The Senate does not have the same requirement. Attorney Porter will further research.
