She recommended that if people choose to use these types of applications they should meet in public places with heavy foot traffic. Trustee Ford requested that the Township Hall allow people to make exchanges in the lobby during business hours.

Lt. Greenlee informed the Board that she has set up directed patrols in both the Skyridge and Whitegate neighborhoods after receiving requests from the neighborhoods and from the Township.

## **Fire Apparatus Discussion**

Fire Chief Barnes presented a memo to the Board explaining the recent certification inspection of engine #532. He is recommending moving up the replacement of this truck from 2019 to 2018 rather than spend money on repair.
