# THE CHARTER TOWNSHIP OF OSHTEMO Township Board Meeting May 12, 2015

Township Board work session was held at the Township Hall. Supervisor Heiny-Cogswell called the meeting to order at 5:00 p.m.

**Update – Kalamazoo County –** County Commissioner Dale Shugars provided information on recent activity of the County Board.

Sgt. Johnson from the Kalamazoo County Sheriff's Department provided information on recent activity in the Township.

Capt. William Timmerman from the Kalamazoo County Sheriff's Department provided activity reports for 2014 and 1<sup>st</sup> quarter 2015.

**Discussion – Trustee Information Request Protocol** – Information regarding procedure for Trustees to obtain and share information from Township staff was reviewed; protocol is needed to preclude e-mail exchanges which would violate the Open Meetings Act.

**Discussion – KABA Lease Agreement –** Supervisor Heiny-Cogswell proposed a three year lease with a one year out clause for KABA space in the Township Office; Attorney Porter will redraft a proposed lease agreement for Board review.

**Fire Department Operations & Programs – 2014 Review –** Fire Chief Barnes presented a report on Fire Department activity for 2014.

**Other Business –** Engineer Elliott provided information on a recent sanitary sewer back up in the Greystone Plat; he advised letters have been sent to effected homeowners and he is waiting for a report from the City of Kalamazoo as to the cause.

The KLA Group has requested letters be mailed to property owners effected by the Groundwater Restricted Zone (GRZ); a public meeting will be held on June 2<sup>nd</sup> at Kalamazoo County.

## KALAMAZOO AMATEUR RADIO LEAGUE USE OF FLESHER FIELD

The 24 hour event is held each year to test the National Emergency Communication System. The event is open to the public and offers opportunity to communicate with other locations worldwide.

Attorney Porter advised since the Kalamazoo Area Building Authority (KABA) has hired a new building official, the Township must also endorse the selection by resolution.
