KALAMAZOO VALLEY INTERGOVERNMENTAL AMBULANCE AGREEMENT (KVIAA)

Fire Chief Barnes advised the current KVIAA agreement with Life EMS will expire in October; RFP's from three applicants, American Medical Response (AMR), Life EMS Ambulance, and Pride Care Ambulance have been reviewed and evaluated by emergency service staff from the four participating municipalities. The recommended agency is Life EMS with a four year agreement with the possibility of up to three, two year extensions.
