OSHTEMO CHARTER TOWNSHIP ORDINANCE

This Ordinance amends Ordinance No. 478, being the Oshtemo Charter Township Truck Route Ordinance, adopted on March 27, 2007, and repeals all Ordinances or parts of Ordinances in conflict.

THE CHARTER TOWNSHIP OF OSHTEMO  
KALAMAZOO COUNTY, MICHIGAN  
ORDAINS:

SECTION I. AMENDMENT OF SECTION II PURPOSE. Section II Purpose of the Truck Route Ordinance is hereby amended to read as follows:

The purpose of this Ordinance is to establish and regulate truck traffic routes to further the betterment of traffic flow, to protect road infrastructure and to mitigate the negative impact truck traffic can have on the community, particularly residential areas, and to do so in a manner that will not result in the diversion of truck traffic onto a border highway; prohibit truck traffic on other roads; and provide penalties for the violation thereof.

SECTION II. AMENDMENT OF SECTION V TRUCK ROUTES. Section V Truck Routes of the Truck Route Ordinance is hereby amended to read as follows:
