DRAFT MINUTES OF A SPECIAL MEETING HELD MARCH 31, 2022

The Oshtemo Charter Township Downtown Development Authority (DDA) Board of Directors held a special meeting at the Oshtemo Community Center, on Thursday, March 31, 2022. The meeting was called to order at approximately 1:00 p.m.

<u>Members Present</u>: Grant Taylor, (attended virtually) Bill Cekola, Themi Corakis, Libby Heiny-Cogswell, Rich MacDonald, Dick Skalski (attended virtually), Ryan Wieber and Ryan Winfield.

Members absent: Stephen Dallas

<u>Also present</u>: Iris Lubbert, Planning Director (attended virtually), Anna Horner, Public Works Director, and Martha Coash, Recording Secretary.

Since Chairperson Taylor was attending virtually, Vice Chair MacDonald chaired the meeting.

<u>Agenda</u>

Vice Chair MacDonald asked if there were any corrections or additions to the agenda. Hearing none, he asked for a motion.

Mr. Wieber <u>made a motion</u> to approve the agenda as presented. Mr. Winfield <u>seconded the motion</u>. The <u>motion carried unanimously.</u>

Approval of Minutes: March 17, 2022

The Chair asked if there were additions or corrections to the Minutes of March 17, 2022. Hearing none, he asked for a motion.

Mr. Wieber made a <u>motion</u> to approve the Minutes of the Meeting of March 17, 2022 as presented. Mr. Cekola <u>seconded the motion</u>. The <u>motion carried unanimously</u>.

Public Comment on Non-Agenda Items

Mr. Corakis noted some snow plow related damage to the new plantings at the corner of Stadium and 9th Street that need to be repaired.

'Music in the Park' Concert Series, Request for Funds

Ms. Lubbert noted a request from Karen High, Parks Director on behalf of Oshtemo Friends of the Parks (OFP) for the DDA's sponsorship as provided in 2021, for a restaurant gift card raffle during the outdoor concerts at Flesher Field. The idea for the raffle came about as a way to support local restaurants impacted by the pandemic. It turned out to be very popular with attendees and also allowed the DDA to promote our local restaurants, and raised nearly \$600 for accessible playground improvements.

The OFP was again seeking DDA support in the amount of \$300 to offset the cost. This would cover the cost of nine gift cards at \$25 each (\$225) plus \$75 for signs and raffle tickets. The raffle will be conducted according to rules from the Michigan Lottery Charitable Gaming Division.

Vice Chair MacDonald made a <u>motion</u> to approve the request for funds in the amount of \$300 to support the 2022 'Music in the Park' concert series raffle as requested. Mr. Cekola <u>seconded the motion</u>. The <u>motion carried unanimously</u>.

Closed Session: Discussion of a Potential Acquisition/Project

Vice Chair MacDonald <u>made a motion</u> to move to closed session to discuss a potential real estate acquisition. Mr. Wieber <u>seconded the motion</u>. The <u>motion carried</u> <u>unanimously by roll call vote</u>.

Mr. Wieber <u>made a motion</u> to return to open session. Ms. Heiny-Cogswell <u>seconded the motion</u>. The <u>motion carried unanimously</u>.

The meeting returned to open session at 2:26 p.m.

Mr. Corakis <u>made a motion</u> to delay the south side Stadium Drive sidewalk project until at least the next regular meeting of the DDA on May 19, 2022. Mr. Wieber <u>seconded the motion</u>. The <u>motion carried unanimously</u>.

Mr. Cekola <u>made a motion</u> to move ahead with a potential acquisition as discussed and agreed to in closed session. Mr. Wieber <u>seconded the motion</u>. The <u>motion carried unanimously</u>.

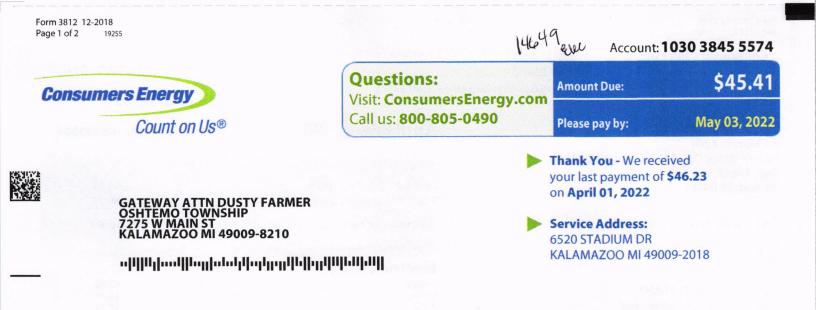

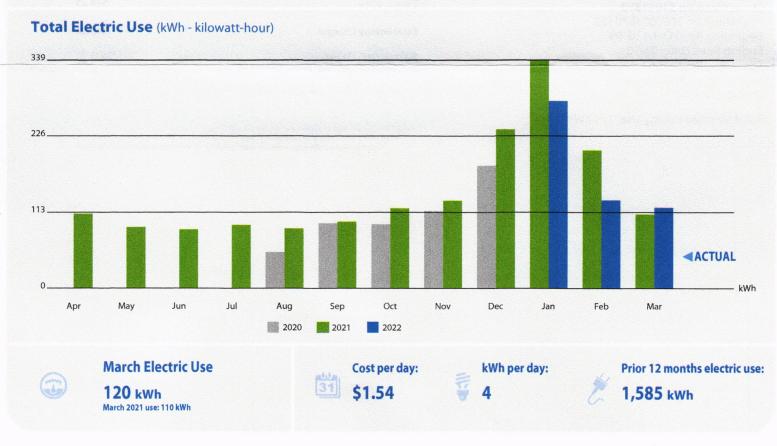

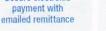
