**NOTICE OF SANITARY SEWER AVAILABILITY  
AND  
MANDATORY SEWER CONNECTION**

TO: THE RESIDENTS AND PROPERTY OWNERS OF THE CHARTER TOWNSHIP OF OSHTEMO, KALAMAZOO COUNTY, MICHIGAN, CURRENTLY ABUTTING AVAILABLE SANITARY SEWER, AND ANY OTHER INTERESTED PERSONS:

PLEASE TAKE NOTICE that available sanitary sewer is defined by Township Ordinance and State law as a public sanitary sewer located within a right-of-way or easement, passing not more than 200 feet from a structure in which sanitary sewage originates.

PLEASE TAKE FURTHER NOTICE that, under Township Ordinance enacted pursuant to State law, Ordinance No. 208, all property owners have 24 months to connect to sanitary sewer after receiving a notification of availability of sanitary sewer letter.

PLEASE TAKE FURTHER NOTICE that, pursuant to Section 8 of the Wastewater Service Ordinance No. 208, the following areas of the Township are hereby provided notice of sanitary sewer availability:

**Residences located in Country Club Village Subdivision on Lodge Lane, Woodlane Drive, Echo Hills Drive and portions Of Clubview Drive;**

**Residences located in West Port No. 1 Subdivision; and**

**All properties abutting the following streets:**

**4th Street from South Township Line to Stadium Drive**  
**10th Street from West Main Street to H Avenue**  
**11th Street from Parkview to Stadium Drive**  
**12th Street**  
**H Avenue from Drake Road to 800' west of 9th Street**  
**9th Street from N Avenue to H Avenue**  
**Atlantic Avenue**  
**Drake Road from West Main to H Avenue**  
**N Avenue from 11th Street to Shane Street**  
**Stadium Drive from 11th Street to O'Park Street**

PLEASE TAKE FURTHER NOTICE that you will receive a mailed notice of sanitary sewer availability from the Director of Public Works.
